




Helping to Ensure the Safety of your On-site Workforce

TRAINING — COVID-19 PROCEDURES

 New workers can easily be added before being issued with PPE, plant and equipment.
- AssetTagz can also prompt the issuer if certain devices should be issued to only one person/operator, for example, radios, mobiles or certain tools.
